#### BACKGROUND

Both disaster risk reduction (DRR) and climate change adaptation (CCA) aim at reducing vulnerabilities and building resilience of people, systems and societies by managing risks and adjusting to the changing climate in order to achieve and sustain development. Resilience building is the shared foundation of the Paris Agreement and the Sendai Framework for Disaster Risk Reduction as well as the 2030 Agenda for Sustainable Development.

The processes of developing policies and investing in risk reduction and adaptation have shared approaches, challenges, and advantages for governance, financing, information and data analysis, capacity development, and monitoring. Despite commonalities and complementarities, DRR and CCA are often planned, financed and implemented in separate ways as they have emerged from parallel global processes. They are also led and managed at country level by different actors and custodian agencies.

Recognizing that greater coherence between DRR and CCA action can help ensuring that development does not exacerbate existing and future risks, and that development gains are protected from the impact of disasters and climate change, the United Nations Office for Disaster Risk Reduction (UNDRR) has embarked on a programmatic approach that focuses on achieving coherence through comprehensive disaster and climate risk management. As part of this initiative, UNDRR has committed to enhance global, regional and national platforms and strengthen national leaderships to foster coherence at the implementation level with the overall objective to leverage synergies and mutually beneficial opportunities across policies to support risk-informed development. Through this initiative, UNDRR hopes to continue providing targeted technical assistance at the regional, national and local levels, especially to developing countries that are particularly vulnerable to the adverse effects of climate change.

In line with the programmatic approach on comprehensive disaster and climate risk management, UNDRR Regional office for Asia and the Pacific, in partnership with the Stockholm Environment Institute (SEI), are conducting a study on the degree of coherence between national policies and plans focusing on DRR and CCA in Asia and the Pacific. This regional analysis aims to enhance our understanding of the level of coherence of planning and policy implementation mechanisms in countries across Asia and the Pacific, and forms the basis for future work in supporting coherent DRR – CCA approaches in the context of the sustainable development agenda in the region.

#### PURPOSE

A desk review of relevant national policy and planning documents has been completed, and key informant interviews with international and regional organizations/development partners and country focal points from DRR and CCA lead agencies have been conducted. We now seek wider stakeholder inputs to validate preliminary findings and gain additional insights on the status of coherence at different scales, to ultimately help identify innovative approaches and understand the opportunities and enabling factors and obstacles to enhanced coherence.
